Age 31 to 35 class. All privileges except the right to vote and sponsor new members.

Entrance Fee: \$75

Monthly Dues: \$154

Age 36. All privileges except the right to vote and sponsor new members.

Entrance Fee: \$100

Monthly Dues: \$171.20

Age 37. All privileges except the right to vote and sponsor new members.

Entrance Fee: \$100

Monthly Dues: \$188.40

Junior/Social

A Social membership available to persons under the age of 40. Use of the entire club except the golf course. There is a contract agreement signed by the member to join for a year at \$600 for the year, billed at \$50 plus tax per month.

Monthly Dues: \$50

Food & Beverage Minimum: \$90 per quarter

Non-Resident Golf I

Available to persons living not less than 20 or more than 50 miles from Ponca City post office. All club privileges except the right to vote and sponsor new members.

Entrance Fee: \$200

Monthly Dues: \$145

Non-Resident Golf II

Available to those living more than 50 miles from Ponca City. All privileges except the right to vote and sponsor new members.

Entrance Fee: \$200

Monthly Dues: \$123

Non-Resident Tennis

Available to those living more than 25 miles from Ponca City. All privileges outlined under tennis membership.

Entrance Fee: \$150

Monthly Dues: \$95

Clergy

All privileges except the right to vote and sponsor new members.

Entrance Fee: \$200

Monthly Dues: \$145
